4. Not to engage in any activity that will injure or otherwise hurt the cats and/or kittens in any manner.

No promises, inducements or agreements not herein expressed have been made, that this Hold Harmless Agreement, Waiver and Release contains the entire agreement between the parties, and that this Hold Harmless Agreement, Waiver and Release shall be binding on the undersigned and his/her estate, heirs, personal representatives, successors and assigns. BY EXECUTING THIS RELEASE, THE UNDERSIGNED ACKNOWLEDGES THAT HE/SHE HAS READ THIS RELEASE, UNDERSTANDS THE CONTENTS HEREOF, HAS BEEN ADVISED AND HAD THE OPPORTUNITY TO SEEK INDEPENDENT COUNSEL OF CHOICE AND CERTIFIES THAT THIS RELEASE HAS BEEN FREELY AND VOLUNTARILY EXECUTED.
